PLEASE NOTE: If you would like Artificial Insemination through a Vet, it will cost \$250 for each visit. This includes semen extraction and mixed with semen extender for the bitch. Price includes shipping the semen or delivering the semen within 1hr of Austin, Texas. If AI is required for return studing, all fees must be paid by Dam's Owner. Sire's owner is NOT required or obligated to pay vet fees for that procedure. The fees listed above include overnight shipping.

STUD OWNER AGREES TO:

1. Provide bitch owner with a complete 4 generation pedigree of the dog.
3. Have the stud dog in good physical condition.

4. Sign litter registration promptly and return to bitch owner or if litter is being registered online, to confirm birth and studing.
 5. Provide 1 (one) return stud service of the same dog to the same bitch if no pregnancy results from the mating, at no charge, the next heat cycle. To receive the return service, the bitch owner must notify the stud dog owner of failure to conceive, in writing, no more than 65 days following the first mating. If the stud is no longer available for whatever reason, for the return service, the stud owner or agent reserves the right to offer a different stud to the bitch owner.
 6. Provide the bitch owner with a written receipt for the stud service
- A record of the breeding dates.

BITCH OWNER AGREES TO:

1. Provide a 4 generation pedigree before servicing (if not before servicing, then before pups are born).
2. Keep the bitch properly confined following the breeding to ensure no other dog could mate her accidentally before mating season is finished.
 - a. If the bitch does accidentally mate or is in the presence of another intact male, bitch's owner agrees to DNA test the entire litter as well as the Dam to determine the correct parentage. Failure to do so will result in no litter registration being signed and no refunds being given.
 - b. If DNA test is needed, it must be done by AKC's (American Kennel Club) DNA program. If another company is needed, then the dam's owner agrees to pay for any DNA or accumulated cost associated with this issue for the sire's owner. Failure to do so means no registration application will be approved.
 - c. If it turns out in the future that the dam's owner wasn't aware another male got to the dam. The dam's owner agrees to take all responsibility for the mistake and to pay for any fees to correct the mistake.
3. Agrees to not knowingly sell or transfer puppies whelped as a result of this mating to any person or firm connected with the business of resale or wholesale of dogs (Puppy Mills, Labs, Pet Stores, etc). If Bitch's owner knowingly sells to a puppy mill, lab, or pet store, then Bitch's owner agrees to pay \$5000 for breach of contract to stud owner. - Please note, sire's definition of a puppy mill is a breeder who has over 30 dogs and most, if not all, is housed in cages.
4. If return stud service is required and stud owner does not have the stud anymore, Dam owner understands the stud owner has the right to use a different stud with some similarities of the original stud including and limited to being within 48 ounces of the original stud's weight, having the same type of registration, and having a nice temperament. If the dam owner declines to use the new studs available, then they forfeit the return studing.

Additional Terms:

Dam owner must notify stud dog owner/agent, in writing, no later than 65 days from the 1st recorded tie/insemination if no pregnancy results from the mating. Proof of not conceiving must be made by X-ray or ultrasound through a licensed Veterinarian (DVM) between 8-9 wks after the first insemination/tie. Proof needs to be given to the stud owner. Failure to do so will result in NO RETURN SERVICE being provided and this contract being terminated. Stud owner will then owe the bitch's owner nothing (no return stud service and no refunds)... It is recommended that even if you think your female is pregnant to get an X-ray done to confirm pregnancy and the amount of puppies.

NO CASH REFUNDS WILL BE GIVEN IF STUD SERVICE DIDN'T TAKE, ONLY REPEAT SERVICE ONCE. Dam owner must initial if understood: _____

If return studding is needed: 2nd studding is done on days: _____

After 2nd studding is done, there will be no more repeat studding through this contract and the agreement will be finished. If bitch owner would like to stud again, they must pay new fee or come up with a new agreement. A new contract must be signed.

The Provisions Of This Warranty Shall Be Interpreted And Construed In Accordance With Laws And Statues Of The State Of Texas. The Venue For Any Litigation Concerning This Warranty Will Be Limited To Travis County, Texas Under A Non-Jury Proceeding.

Bitch's owner agrees that all dealings and actions done by both parties concerning this transaction are between the two. Buyer understands that all information and actions concerning this agreement and the transaction between both parties concerning this puppy should be kept confidential unless the seller gives written or emailed permission. Buyer understands that failure to comply with this agreement means that the Dam's owner is in Breach of this contract and will give Travis County, TEXAS small claims court maximum for the breach. If any legal action is taken by the Bitch's Owner, they are limited to Small Claims Court only at the county the Sire's Owner resides.
